He had a general understanding about the UN in preparation for the written test used to select a delegate. But this understanding was broadened by his actual visit to the UN and listening to the speakers at their meetings. Based on this experience his view of the UN changed and he

now understands what an important role they play in international affairs.

As a thank you to District 10 Abram put together a slide program of the pictures he took during the trip We used his DVD as part of our presentation to students about this wonderful educational experience. We will show this DVD at our District Meeting on April 12th and include a short discussion by our two participants about their experience. On February 24 the competition for the 2008 program was kicked off in Orofino at the Blue Bell Rebakah Lodge. We had a total of 6 High school students and parents attend the day's competition. IS YOUR UNIT INCORPORATED???

According to directions, each unit is to be incorporated with the State of Idaho. Do you fill out a report from the Secretary of State each year showing the current officers of your lodge??? If you haven't, then it is a real possibility that you have let your corporation classification lapse. You might contact the Secretary of State office and check to see if you are current if you are not sure. (Phone # 208-334-2300) It did cost approximately \$30.00 to reinstate, but you have to request the forms to fill out.

D.V.D's of "The Degrees of Our Order" are now available from the Grand Lodge for order. The cost of the 4 DVD's is \$50.00 plus S/H.

Your lodges will be receiving an update for the Funeral Aid Association and the need for the support of that section of our organization. From July through March we have lost 11 members of the Association and the membership is dwindling, so I would encourage each of you to participate.

The current updates of The Grand Lodge Constitution and By-Laws are available at the Grand Lodge office. They are 3-hole binder size. Complete with binder they are \$15.02 plus shipping & handling. The current 2007 Code of General Laws changes are also available. The cost is \$3.36 plus shipping & handling, so it would behoove the lodges to order in one bunch to save funds.

Remember, there are also Past Grand Jewels and Certificates available for the ordering as well as all other needs of the lodges. If the lodge Rituals and your Charge books are not up to date, you are not getting the job done.

SECRETARIES, when a new member is initiated into your lodge, please send that information into the Grand Lodge so the data base can be updated. I will notify the paper and the Sovereign Grand Lodge for you. Thanks. The Directory cannot be correct if the lodges do not render information to be utilized. GREETINGS FROM THE GRAND MASTER Dear Brothers and Sisters:




Thanks for all the recipes I have been receiving. The sale of the cookbooks will also benefit our paper.





GLENN P. CHANEY

Glenn Philip Chaney passed away peacefully from congestive heart failure on December 11, 2007, in a local care facility. He was born to Nellie A. and Ira R. Chaney on November 16, 1919, in the family home at Stanton Crossing on the Big Wood River, south of Bellevue, Idaho. Glenn was educated at the Stanton School until it closed. He then attended and graduated from Bellevue High School in 1936. He went to college in Gooding for a short time, but, after the death of his father, he returned to Big Wood River to join his brother James in operating the Chaney Hereford Ranch.

In 1940, Glenn married Ruth May Scott. Glenn and Ruth ranched until 1962 when they sold the ranch and moved to Nampa, Idaho. Glenn worked as a self-employed carpenter. Glenn and Ruth were very active in the Odd Fellows Lodge and Glenn was elected to serve as the Idaho Grand Master in the 1960's. In the late 1960's Glenn and Ruth bought a retirement home in Cascade, Idaho, where they spent many weekends fishing. Glenn's favorite hat said it all for him: "Fishing is not a matter of LIFE and DEATH—it's much more IMPORTANT than that!"

Ruth died unexpectedly in 1984 and in 1986 Glenn married Gladys Springer.


Glenn and Gladys lived in Nampa, Hailey, and Boise, and wintered in Yuma, Arizona, until ill health forced them to remain in Boise. Following Gladys' death in 2006, Glenn lived with his daughter and son-in-law, Glenda and Gene Blessing. He went to work with them every day and spent the winter with them in Mexico.

Glenn experienced the "good old days" in his golden years, telling stories about cattle drives, sleigh rides to town, boarding out at school with only one change of clothes, and the antics of dogs, hired men, siblings, and more.

Glenn is survived by his daughter Glenda (Gene) of Boise, son Phil (Beverly) of Middleton, Idaho, son Don (Donna) of Centennial, Colorado; grandchildren Michael Blessing, Jana Hyland (Gary), Lisa Chaney (Lee Brown), Jeff Chaney (Carol Gilenko), all of Boise; Justin Chaney (Debbie) and Erin Moose (Michael), of Denver, Colorado, and several great grandchildren. He also leaves behind a stepdaughter, Carol Springer of Boise, a stepson, Dan Springer (Julia) of Hailey and three step great grandchildren. Step grandchildren include Matt Springer (Jamie) of Pine, Kate Stechelin (Mart) of Germany, and Maggie Springer of Hailey. He was preceded in death by his two wives, his mother and father, his two sisters and four brothers, three of whom were the first triplets born in Idaho.

Glenn will be cremated and his remains will be placed alongside his wife Ruth in Bellevue. A grave side service will be held at Bellevue cemetery, June 12, 2008 at noon; under the direction of the Bowman Funeral Parlor, Garden City. Glenn was a gentle man and will be fondly remembered by those he leaves behind. The family wishes to thank the wonderful caregivers at the Valley View Life Care Center for their care and concern during his final days. Betty Berdeen (Backer) Brandau

Betty was born July 18, 1922 in Nampa, Idaho to Byrdie (Laura Ann) Samuel and Chris (Christopher John) Backer and passed away February 3, 2008 in Boise, Idaho. The midwife who delivered Betty was a little hard of hearing and when she filled out Betty's birth certificate wrongly recorded her middle name as "Verdene". She was the youngest of four children, earning her the lifelong nickname of "Babe". Betty was raised in the Lone Tree Community and attended Nampa schools. She loved to play softball and was proud of being a great pitcher. After completing high school she attended Lewiston State Normal School in Lewiston, Idaho and received her teaching certificate August 14, 1942 and her college diploma on May 24th 1943. She was hired for her first teaching job, 1941-42, by her Lone Tree neighbor Vernon Woodman, then Principal at Central in Nampa where she taught 8th grade boys PE. Although that was an unusual position for a woman she quickly earned the boys respect as a baseball player during the first week of school by connecting with a good pitch sending the ball clear over the fence and across the highway. Her second year of teaching, school year 1942-43, was at the one room schoolhouse in the Wilson Community in Owyhee County. The teachers then would usually board with a member of the community. Betty stayed with Clifford and Gertrude McMahan. She met Cliffords friend and Gertrudes brother, Henry Brandau while staying with them. They started dating, going ice skating, to movies and playing cards with friends.

Betty and Henry were married on May 29, 1944 in Nampa Idaho. They moved to Melba, just north of the Butte, where they farmed. Their daughters, Becky and Merle were born while they lived there. In 1946 they purchased the home place on Reynolds Creek from his parents and moved to the Schuster place while Henrys parents, George and Minnie, built a new home. Two weeks after the birth of their son Richard, in 1948, they moved into the house on the ranch where they would live for the next 55 years.

Betty devoted her life to her family. She was a 4-H leader, hauled kids to ball games, 4-H meetings, and the County fair. She always had a meal ready or coffee and sweets for anyone who dropped by. She had a passion for "doing ceramics". She and Henry loved to play pinochle, both at home with friends and family, and at community pinochle parties at the Wilson Schoolhouse. Betty was a charter and life long member of the Wilson Sage Hens, a ladies group founded in 1949. She was a life long member of the Melba Rebekah's Lodge and helped every year at the Melba Community Auction. She was proud of the article in the county paper that publicly recognized her for more than 50 continuous years of serving on the Wilson election board. She was chosen as Citizen of the Year by the Melba Community (and given a place of honor in the 4th of July parade) and cherished the plaque she received. Betty worked at the Melba schools as both a substitute teacher and as secretary of the Melba Grade School until she retired in 1980. She took up league bowling and got to travel a bit with her bowling buddies. Betty loved to sew and cook and was famous in the Valley for her rolls and her giant Valentine sugar cookies. She hated house cleaning and yard work much preferring to spend her time on social activities and shopping. But most of all she was a great Mom and wonderful "Grammaw Betty".

A decline in health precipitated a move to SunBridge Healthcare in the fall of 2003. Betty recovered and moved into SunBridge Retirement in order to stay near Henry. She visited him faithfully everyday making the trip on her power chair that we all called her "little red convertible". Betty moved into assisted living at SunBridge in the spring of 2007 and deteriorating health sent her back into total healthcare in November.

Betty was preceded in death by her parents, Byrdie and Chris Backer; her brothers Bill and Harold Backer of Seldovia, Alaska; her daughter Merle Malmberg of Marsing, Idaho; a grandson Jeremy Stewart of Casper, Wyoming. Her immediate surviving family are her sister, Adella McMahon, Portland, Or; her daughter and son-in-law Becky and Don Stewart of Casper, Wyoming, former son-in-law Bruce Malmberg and his wife Nancy of Marsing, Idaho, son and daughter-in-law Richard and Connie Brandau of Wilson, Idaho; grandchildren: Shelly and David Petzold, Middleton, Wisconsin; Cindy and Jack Truitt, Oak Point, Texas; Joe and Yayoi Malmerg, Nagoya Aichi, Japan; Barry and Anna Malmberg, Philomath, Oregon; K.C. and Kristine Brandau, Meridian, Idaho; Jody and Kyle Moos, Wilson, Idaho; great-grandchildren: Ashley and Shelby Brandau; Hannah Moos; Rachel, Paul and Eli Petzold; Axel Dylan Malmberg; Kate and Rio Malmberg.

Funeral services was held on February 9th under the direction of Alsip Funeral Chapel, 404 10th Avenue South, Nampa, Idaho. After the service friends and family were invited to share memories and dinner at the Melba Senior Center, 115 Base Line Road, Melba, Idaho.
